# Council Hears Details of Recent Timber Ridge Drug Bust

Captain Jack Wood informed the council of the details surrounding a recent drug bust that occurred the weekend of March 23 at the Timber Ridge Apartment parking lot, “ I saw two guys sitting in a black Nissan and they were smoking marijuana. It got my attention so I got out and I could smell the marijuana. One thing I could say about the two guys (identified as Malik Burns and Antavius Merrell). I’ve never seen anybody be so honest. They gave me no trouble, they cooperated and when I asked them about the marijuana, they said, ‘Yes sir, we just put it out.’ I said, ‘Can I see it?’ and they showed me. All the drugs that I retrieved were handed to me by them. I didn’t have to search the car and

they had marijuna and cocaine. So, they were charged with possession of marijuana with intent to distribute and possession of cocaine with intent to distribute and it was crack cocaine. It was in one single bag and they actually had the price written on it. I didn’t have to draw my gun and they didn’t draw a crowd or anything and everybody co-operated. After that, I called the county to transport and then I found the money totaling a little over \$11,900. The one thing I was proud of is, I didn’t have to pull my weapon and there was no resistance.”

Interim Police Chief Castonio Lucas also stated that due to a lack of manpower he requested that all, “The parks shut down at 8:00 p.m.”

Following discussion, the council agreed to change the

curfew at all city parks that had been set for 10:00 p.m. to 8:00 p.m. due to a lack of manpower at the police department. Officer Lucas continued, “People that own their property, they’ve got the right to have a gathering, but whenever that gathering is out of control, that’s where we come in. We’re going to shut it down and they will be charged, no questions asked.” Also due to a problem with radio calls, it was suggested that the city consider going back to using analog radios for better communication. City Clerk Margaret Shelley recommended and the council agreed to hire Jamie Ward who lives in Vienna, Ga. as a cash collections clerk. Officials also addressed concerns

## Council-Mayor Working to Make Unadilla, “Jewel of the County”

I want to update you on the new progress that is being made in our great city. East Railroad Street going towards the state prison resurfacing project will begin before the summer. I’d like to thank Senator Larry Walker for his help in obtaining these emergency funds to fix this eroded roadway.

Next we also received special LMIG funds to resurface Duncan Street, a street that has needed attention for decades. This project will start in the next couple of months.

Since I became mayor in 2016, the city council and myself have engaged in an aggressive street resurfacing campaign. Our citizens deserve better roadways and they’re getting them one street at a time, sometimes two at a time like this year.

Another update is on our new city splash pad for our kids. We put money in our new SPLOST fund to build a state of the art splash pad and we’re now looking at contractors to get ideas on what we want.

This is the type of thing that our youth need to make their summers fun.

I also want to let you know the contract was approved to repair the floor at the Unadilla Blue Devil Gym, and should be completed before summer. Again this will be a big plus to our summertime activities for the kids.

One last update on the new truckstop coming. I talked to the demolition manager for the project and he said tear down will begin in April, that includes the old truckstop, old fuel tanks, old asphalt, and the old motel next door. Jones Petroleum has said the new fuel stop will be completed by the end of the year.

In this same line, the owners of the old Days Inn next to the Sunoco station, purchased a demolition permit from the city to tear down that eyesore. I want you to know that myself and the council are working hard to make Unadilla the jewel of the county and more things are coming.

## Unadilla Funding Repairs to Gym Floor in the Near Future

Unadilla Mayor Myron Mixon provided an update on repairing the gym floor, “We got Ted Williams who’s been in the business a long time from over in Hawkinsville who came over and looked at the floor and to replace all the rotten boards and sand it all down, put the lines back. Put us a Blue Devil in the center of the floor and refinish the whole thing and reseal it for \$28,000. It will be six weeks out but we need to fix the gym if we’re going to fix it. We’ve got the money in the budget for it.”

Following discussion, the council approved the cost estimate of \$28,000. The mayor also provided information on the situation regarding the Truck stop, “They’re fixing to start tearing it down, tearing the asphalt out, tearing down the hotel and they said they’d be done by the end of the year, completed and open. The people that owned Days Inn told me at the end of last year that they were going to start tearing it down. They looked at the feasibility of fixing it, to try and put a hotel back to do apartments. They said it wasn’t feasible for that.”

Also he talked about some good news on this year’s SPLOST, “We just paid off the community center on last year’s, we put in a Splash Pad for the children here in the city, so we’re moving forward with the Splash Pad for the kids.”

He also commented about another project, “If everybody goes up Elko Road and Highway 41, you’ve seen a lot of growth going to the county line. We need to be thinking

I've been a law man all my life and I've been very fortunate to be in places and meet good people who have taken an interest in me in what I've done. Writing is my way of staying sane. I

write myself into situations and I write myself out of 'em and it helps me to stay sane. I'm doing a few poems, but mostly essays now on what I think about things, etc.

I'm still working, I write everyday. If my steering wheel would listen, I wouldn't have to write as much because I talk to

my steering wheel. It's all just been overwhelming to me, I just write; I'm just very blessed as we all really are when you think about it. I'm not thinking about all the symbolism and stuff like that when I'm writing. You write what you know, you write what you feel and I used to like to write to instrumental music,

very slow, very relaxing music and I write early in the morning generally between five and six o'clock. Sometimes, I'll wake up at night and write."

## In The Garden With PROPER TOMATO PLANTING

Spring has sprung and it's time for many of us to start preparing for the best crop of tomatoes ever! Some of you can boast of having a fine tomato crop last year and some of you can't but, as they say, there's always next year. Well, "next year" has arrived and hope springs eternal.

Meanwhile, I have recently discovered some very interesting things about our favorite garden fruit-the tomato. There are those who have studied the internal workings of all kinds of vegetables, including tomatoes. Their findings suggest that some of the things we have been doing with our tomatoes have perhaps not been in our best interest at all.

Most of us like to plant our tomatoes early, hoping for an early harvest. And some of us plant our transplants as deep as possible after removing one or more leaves, thinking that they will grow more roots along the stem. More roots equal more leaves and stems equal more tomatoes. Not necessarily.

Experiments were conducted in which different numbers of leaves were removed from

tomatoes at transplant time. Later, the root systems of these plants were examined. Those with no leaves removed had the largest root systems. Surprisingly, those that had all but the top cluster of leaves removed grew almost no new roots at all, from neither the original root ball nor the part of the stem that was buried. In fact, since those plants had no energy to grow new roots, it took eight weeks for them to recover, according to the researchers.

Ideally, plants should be set out in the garden just a little deeper than they were planted in the container. Generally, the container should be at least three inches in size for best root growth. Plant the transplants up to the first set of leaves. Don't remove any healthy leaves at all. Tomatoes do have the ability, as advertised, to grow roots anywhere along the stem, but every single leaf is important, if it is green and healthy. Ostensibly, removing a leaf reduces the energy that a transplant will have for making new roots.

The research suggests, however, that if the plant is pot

bound and leggy, it is best to go ahead and bury the stem. Why? Because it probably won't be able to grow many new roots, and most of the new roots will form above the root ball along the stem anyway. But, removing any healthy leaves under any circumstances is not recommended, because they are needed to grow new roots.

It is also a bad idea to set out a tomato plant with any fruit on it. That one fruit, it is thought, will hog practically all the nutrients available to the young transplant. What we growers need to be doing is encouraging the growth of new roots, since a good crop of roots means a good crop of fruits later on. But with a developing fruit attached, the plant directs most of its energy to the fruit at the expense of new root production. Plant development will also be delayed several days. According to the research, once a plant has a full fruit set on it, the roots don't grow any more at all.

If you have a tomato transplant with even one fruit on it, it is best to remove it and let the plant develop more roots instead. You will be much better off in the long run.

Moreover, I suspect that the aforementioned principles will apply to peppers as well.

Years ago Daddy told me a story about laziness that dates back to the early days of farming, the era of mules and hand tools. A local fellow, whose name I've long forgotten, was relaxing on his front porch in a rocking chair, unconcerned about the abundant weeds competing with his young cotton.

A well-intentioned neighbor stopped by, hoping to encourage some much-needed effort. "I believe that nutgrass is going to eat you up," he said to his friend. "It may," replied the man, "but it'll have to come up here on the porch and get me." The level steps of laziness require little effort and offer commensurate rewards.



## Parables To Ponder HISTORY OF THE BIBLE

The history of the Bible starts with a phenomenal account of history! It's not one book like I always thought -- It's an ancient collection of writings, comprised of 66 separate books, written over approximately 1,600 years, by at least 40 distinct authors. The Old Testament contains 39 books written from approximately 1500 to 400 BC, and the New Testament contains 27 books written from approximately 40 to 90 AD. The original Old Testament was written mainly in Hebrew, with some Aramaic, while the original New Testament was written in common Greek. The history of the "Bible" begins with the Jewish Scriptures. The historical record of the Jews was written down on leather scrolls and tablets over centuries, and the authors included kings, shepherds, prophets and other leaders. The first five books are called the Law, which were written and/or edited primarily by Moses in the early 1400's BC. Thereafter, other scriptural texts were written and collected by the Jewish people during the next 1,000 years. About 450 BC, the Law and the other Jewish Scriptures were arranged

by councils of rabbis (Jewish teachers), who then recognized the complete set as the inspired and sacred authority of God (Elohim). At some time during this period, the books of the Hebrew Bible were arranged by topic, including The Law (Torah), the Prophets (Nebim), and the Writings (Ketubim). The first letters of these Hebrew words - T, N and K -- form the name of the Hebrew Bible - the Tanakh. 1

Beginning as early as 250 BC, the Hebrew Bible was translated into Greek by Jewish scholars in Alexandria, Egypt. This translation became known as the "Septuagint", meaning 70, and referring to the tradition that 70 (probably 72) men comprised the translation team. It was during this process that the order of the books was changed to the order we have in today's Bible: Historical (Genesis - Esther), poetic (Job - Song of Songs), and prophetic (Isaiah - Malachi). 2 Although the Jewish Scriptures were copied by hand, they were extremely accurate copy to copy. The Jews had a phenomenal system of scribes, who developed intricate and ritualistic meth-

ods for counting letters, words and paragraphs to insure that no copying errors were made. These scribes dedicated their entire lives to preserving the accuracy of the holy books. A single copy error would require the immediate destruction of the entire scroll. In fact, Jewish scribal tradition was maintained until the invention of the printing press in the mid-1400's AD. As far as manuscript accuracy, the recent discovery of the Dead Sea Scrolls has confirmed the remarkable reliability of this scribal system over thousands of years 3 (I'll get back to the Dead Sea Scrolls later).

After 400 years of scriptural silence, Jesus arrived in 4 BC. Throughout his teaching, Jesus often quotes the Old Testament, declaring that he did not come to destroy the Jewish Scriptures, but to fulfill them. In the Book of Luke, Jesus proclaims to his disciples, "all things must be fulfilled which were written in the Law of Moses and the Prophets and the Psalms concerning Me." From 40 to 90 A.D, the eye-witnesses to the life of Jesus, including Matthew, Mark, Luke, John, Paul, James, Peter and Jude, wrote the Gospels, letters and books that became the Bible's New Testament. 2 Timothy 3: 16-states: "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness."

about expansion and we've also got some expansion that's going west of us, especially around the Industrial Park at the overpass where Angel City is located. We've also got some going south even possibly past Lasseter, so we need to give an update that we're starting back the process of looking where we're going to move our boundaries. We've already got a price to be able to do gas service up Highway 41 and up Elko Road because if you're going to expand, you've got to provide service. We can put in gas on both Elko and Highway 41 to the county line for around \$58,000. We can get a grant for water and sewage, but you can't get a grant for gas because you make money off of gas.

We need to expand our city limits. Our city limits are gerrymandered like you wouldn't believe. Certain people didn't want their land, house or property in the city limits when they were paying the county. When they sold

some of it, they didn't care what you did with it as long as you didn't tax them. That's not the way this works. People that use our services and come under the umbrella of protection for the fire department and water and sewage, they need to be paying if they own it."

Mr. Mixon also reported on the East Railroad Street project including the road leading to Dooly State Prison that has been funded and 'let'. It was announced that it will start sometime between now and May or the early part of summer. The resurfacing will cover the roadway to the city limits. Unadilla in cooperation with the engineers have received some emergency LMIG funds for the resurfacing of Duncan Avenue. The City of Unadilla gave a greenlight and accepted a quote from Contender to repair the city's vehicle, a Ford Taurus. The council approved a business license for 'Video Perfection' who sets up AV sound system equipment for

corporate, personal functions such as birthday parties and weddings, etc.

Public Works Director Leon Lester reported on his department's activities, "We're still doing 811 calls, putting in water meters and repairing water leaks and we had a steady leak here between Giant Foods and the Subway at the vacant field. We did install a couple of meters and we got a couple of doors (a roll up) put in at the shop where the gas department is located and chain hoists on the three roll up doors at the regular shop."

The council also approved the lease on the new Kubota Excavator. Fire Chief Justin Bridges reported that during the month of March calls had responded to seven calls including one vehicle accident, one vehicle fire, one grass fire, one pole fire, one EMS medical assist, one Air Evac landing zone standby and one trouble unknown with no incident call. Unadilla FireRescue has responded to 31 calls so far this year.

over changes being made by the county regarding how customers will be billed for trash collections by Waste Management.

Els Rombaut with Fruits of Vienna Bed and Breakfast spoke to the council on representing, “A united group of business owners and community members, to propose a collaborative initiative that will revitalize our city and enhance its appeal for both residents and visitors alike: a comprehensive Spring Cleanup and Beautification Project. A deep cleaning of street gutters, removing debris and preventing potential drainage issues. Careful removal of weeds from sidewalks, parks, and public areas, creating a more inviting environment. Pressure washing to remove grime and revitalize public walls, showcasing our city's pride. Strategic placement of decorations and seasonal plantings to create a vibrant and welcoming atmosphere.”

Ms. Rombaut also suggested, “Creating and distributing flyers to all businesses, promoting the Spring Cleanup Day and encouraging participation. We suggest organizing the cleanup efforts by city blocks, fostering a sense of neighborhood

pride and friendly competition. To further motivate participation, we propose the city provide gift cards to the block that demonstrates the most significant transformation, rewarding their collaborative efforts and inspiring others.”

She also suggested, “Coordinating with the local high school to involve 11th and 12th-grade students in the cleanup efforts as part of their community service requirements. We understand that these efforts require resources, and we are prepared to partner with the city in a meaningful way. A group of local businesses has committed to providing volunteer labor. Additionally, our esteemed Garden Club has graciously offered to spearhead the beautification of our city entry signs, creating a stunning first impression for all who arrive. To further enhance the impact of this project and to clearly communicate the collaborative spirit between the city and private businesses, we propose the installation of a signage pole at a prominent location at the corner of 41 and Union Street at the square on where to find businesses like pharmacy, lunch place, take out food, thrift store, antique mall, Bed and Breakfast, auto repair, hairdressers. This signage would serve as a testament to our community's commitment to working together for the betterment of Vienna.We believe that this Spring Cleanup and Beautification Project will
