

Holy Communion and Benediction was led by Bishop Robin Dease and Reverend Jeff Cleghorn, pianist, who provided worship music and the new roof dedication.



New this year, we're hosting a graphic arts contest for our 90's theme, 'Getting Piggy Jiggy With Us.' You have until Sept. 30 to get those submissions in and the winner will get \$200."

Both the chamber of commerce and family connection will be participating in the Trunk or Treat and the Not so Scary Reading event at Dooly K-8 Academy Oct. 24 beginning at 9:30 a.m. for around 700 children as well as Reading with Santa and 'The Reason' activities.

Brenetta Childs, election supervisor, reminded attendees about the upcoming special election-municipal general election where all county voters are urged to return to the polls to vote in a public service commission election, while Vienna residents will vote for the seat currently held by Walter F. 

In The Garden With GROWING SWEET ONIONS

Onions are one of the few vegetables that can be planted from late September to late October in middle Georgia. Since Georgia has become internationally known for the world-famous Vidalia onion, and since they are so good, many gardeners have asked how to grow this unique onion.

The characteristics (size, shape, color, sweetness, etc.) of the onion bulb that will be harvested next spring can be directly attributed to two factors—genetics and environment. We determine what those onions will be like by our selection of the appropriate genetic material (variety) and by properly managing the environment.

Genetics first. There are many onion varieties available to gardeners. All of these fall into one of three day-length groups: short day, long day, or intermediate. The short day group contains the true Vidalia onion as well as the Vidalia types.

Why is day length important when it comes to growing onions? Bulb formation in onions is primarily a day length response. In short day onions, bulbing begins when a day length of approximately 11 hours occurs. In Georgia, this day length is usually achieved

not buried too deeply or rotting may occur. Space plants 6 inches apart in furrows 12 inches apart.

(3) Maintain a soil pH of 6.0 to 6.5 and provide an adequate supply of nutrients. Apply no more than one ounce of actual sulfur per 150 square feet and do not apply sulfur after December 31. Onions are heavy feeders, so don't be shy with the fertilizer!

(4) Onions roots are shallow and not very efficient at taking up moisture, so they need a steady supply of water to grow without interruption. Although they actually recover well from drought and start growing again when watered, it is best to keep the soil consistently moist until the bulbs enlarge.


(5) You may mulch with a light layer of weed-free and herbicide-free grass clippings or other fine mulch. Onions naturally push toward the surface as they form bulbs and it is best if the tops of the bulbs are allowed to bask in dry sun. Remove mulch that might keep the expanding bulbs excessively moist.

Some gardeners will find it difficult if not impossible to grow the very sweet, mild "Vidalia type" onion. Heavier soils tend to hold more sulfur and such soils may contain enough residual sulfur to make onions hot. Try it anyway—you might be pleasantly surprised!

Parables To Ponder APOSTLE PAUL'S VISION OF THE THIRD HEAVEN

In 2 Corinthians 12: 2-4, the Apostle Paul reveals he was transported to heaven: "I know a man in Christ who fourteen years ago was caught up to the third heaven—whether in the body or out of the body I do not know, God knows. And I know that this man was caught up into Paradise—whether in the body or out of the body I do not know, God knows—and he heard things that cannot be told, which man may not utter." In the ancient world, the first heaven consisted of the earth and its atmosphere. The second heaven was the region of the sun, moon, and stars. The third heaven was the dwelling place of God.

The man to whom Paul alludes is the apostle himself. His vision of the third heaven was inexpressible, meaning that words were insufficient to describe what he experienced. Paul experienced unsurpassable ecstasy in his nearness to God. He did not know whether his body and soul were caught up to the third heaven or whether his soul temporarily

went out of his body, as he explains: "Whether in the body I do not know, or out of the body I do not know."

My granddaddy Powell once told me that he fainted while working outside in the hot sun, evidently from a heat stroke. During his swoon, Granddaddy said he went to a beautiful place like heaven. When I asked what he saw, Granddaddy said that words were inadequate to express what he experienced. Granddaddy's journey may have been similar to Paul's. Paul's foretaste of life in heaven with Christ may have influenced him to write Philippians 1:21: "For me to live is Christ, and to die is gain."

Paul doesn't state the reason for his trip to heaven. It may be that God granted Paul this personal experience to steel him against the suffering he would experience on his missionary journeys. Paul was shipwrecked, imprisoned, beaten, stoned and left for dead, and in the end beheaded by the Roman Emperor Nero.

Having glimpsed the ineffable beauty of heaven that awaited him, Paul was able to face the trials he suffered.

The Bible discloses that both Enoch (Genesis 5:24) and Elijah (2 Kings: 2:11) were taken up bodily into heaven. Isaiah was not transported to heaven, but had this vision of heaven. "I saw the Lord sitting upon a throne, high and lifted up; and his train filled the temple. Above the Lord stood the seraphim; each had six wings: with two he covered his face, with two wings he covered his feet, and with two wings he flew..." John the Revelator was carried away in the spirit to a high mountain. There he saw the Holy City whose streets were pure gold. "I did not see a temple in the city," wrote John, "because the Lord God Almighty and the Lamb are its temple." John continues: "The city does not need the sun or the moon, for the glory of God gives it light, and the Lamb (Jesus) is its lamp."

Even though we have not experienced heaven as Paul, we can claim the assurance of this scriptural promise: "Eye has not seen, nor ear heard, nor have entered into the heart of man, the things which God hath prepared for those who love him" (1 Corinthians 2:9).




